LITIGATION

Litigation is a process of taking dispute in law or a claim to a court of law for resolution. It is a complex area of law which involves the representation of clients in court. Our team of legal experts are highly knowledgeable and skilled in the procedures of the various courts . The Litigation process includes but not limited to:

- Drafting of pleadings and opinions
- Drafting of summons, application, affidavit and any other documents to initiate proceedings in court
- Drafting of notices throughout the proceedings
- Acting as mediators and attending to settlement negotiations

Commercial law

Commercial law refers to the body of laws that govern business and commercial transactions. At Mulangaphuma N Attorneys Inc, we understand the importance of protecting our clients business interests, and as such we provide commercial law services which includes but not limited to:

- Reviewing, Vetting and drafting of any business agreements
- Providing advice on legal implications of any action to be taken and considerations resulting from commercial agreements.

Construction law

These refers to the body of laws and regulations that govern construction industry. It encompasses a wide range of topics, including contract laws, Tort law, Property law and labour laws as they all relates to construction projects. Third Party Claims (RAF & Medical Negligence)

At Mulangaphuma N Attorneys we assist our clients to claim for compensation for injuries, or loss sustained either against the Road Accident Fund or the Minister of Health for any medical negligence suffered at any Hospital at the hands of medical practitioners.

- **RAF** - Claims against the road accident fund are claims for compensation for any injuries or loss a person suffers as a result of a motor vehicle accident that occurred on any road in the Republic of South Africa. This claim can be instituted by any person who was in the car during the accident, be either the driver or passenger.
- **Medical negligence** - This is a process of seeking compensation for injuries or harm caused by a healthcare provider's failure to meet the standards of care. These claims can be very complex and may involve multiple parties such as Hospitals, Doctors, Nurses and other medical practitioners. These include medical negligence such as but not limited to:
 - * Surgical errors, Misdiagnosis, Medication errors, Birth injuries, Hospital acquired infections

Contracts & Lease agreements

These are legally binding documents that outlines the terms and conditions of a business relationship or arrangement. These documents can help protect the interests of all parties involved and provide clarity on the expectations and obligations of each party.

* Law of Contracts

These are set of rules and regulations that govern the formation, performance, and enforcement of Contracts. A contract is a legally binding agreement between two or more parties that creates a mutual obligation to perform specific actions. These includes contracts such as: Service contracts, Sales contract, Employment contract and Partnership contracts. At Mulangaphuma N Attorneys, we can assist with contracts related tasks such as: Drafting and reviewing contracts, Negotiating contracts terms, Ensuring compliance contract laws and regulations, Assisting with contracts disputes and breaches.

* Lease agreements

These is a contract between a landlord (lessor) and a tenant (lessee) that outlines the terms and conditions of renting a property. The agreement specifies the rights and responsibilities of both parties and provides a framework for the rental relationship. Labour and Employment Laws

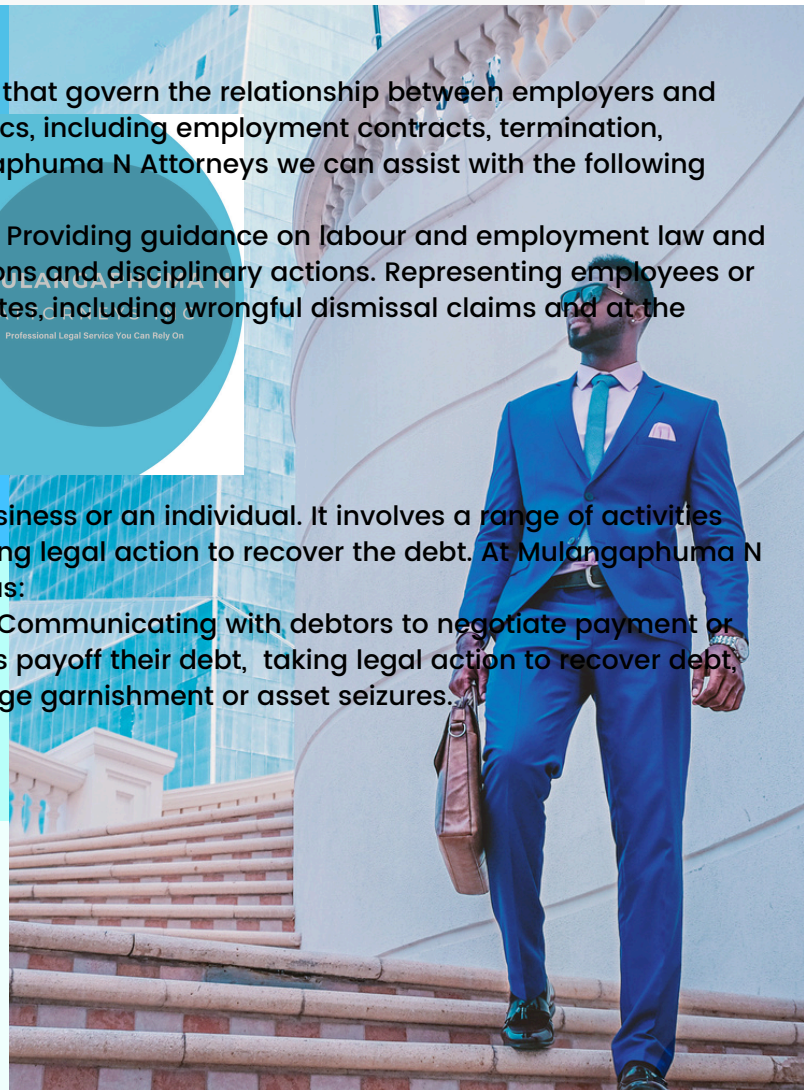
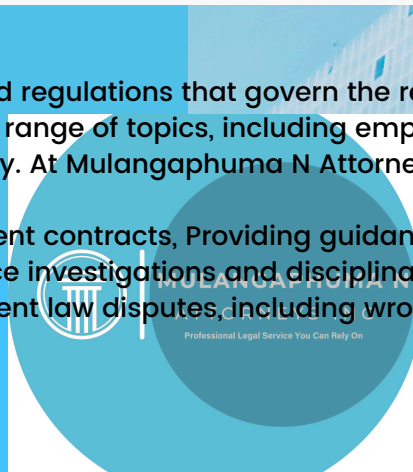
